

WARRANTY AGREEMENT

SuperGalum[®]


KG Dongbu Steel

KG Dongbu Steel co., ltd. warrants to Buyer that KG Dongbu Steel's hot dipped aluminum-zinc alloy coated steel sheet, sold for use as **painted, unpainted or resin-coated roofing and siding panels or for use in rainwater applications**, if erected within Continental North America or in another location pre-approved by KG Dongbu Steel, will not rupture, fail structurally or perforate within a period of **twenty five (25) years and six (6) months** after shipment from KG Dongbu Steel due to exposure to normal atmospheric corrosion.

This warranty applies to all categories of product with a metallic coating class of **AZ50(AZM150) or heavier** as designated by ASTM specification A792/A792M.

This warranty does not apply to SupreGalum steel sheets exposed at any time to corrosive or aggressive atmospheric conditions, including but not limited to the following :

- Salty coastal areas or areas exposed to constant spraying of either seawater or fresh water.
- Areas subject to fallout or exposure to corrosive chemicals, fumes, ash, cement dust or animal waste.
- Areas subject to water run-off from lead or copper flashings or areas exposed to or in metallic contact with lead or copper.
- Conditions or environment where corrosive chemicals, fumes or condensates are generated or released inside the building.
- Areas precluded from periodic washing by natural rainfall or man-made fresh water rinse.
- Parts subject to direct contact with or exposure to CCA(Chromated Copper Arsenate) treated lumber (outdoor wood) or fire/flame-retardant treated wood shakes or siding.

This warranty does not apply in the event of the following:

- Bends of 4T or less for a sheet with thickness of 0.091"(2.3mm) and thinner.
- Slopes of a roofing or any sections of a roofing 1/4: 12 (or 1°) or flatter.
- Mechanical, chemical, or other damages sustained during or after installation, during shipment, storage, forming, or painting.
- Damages caused to the metallic coating layer by severe reverse bending, alternating compression and tension process, improper roll forming, refining or scouring.
- Failure to remove debris (contamination) from or to provide for free drainage of water in overlaps and all other surfaces of the sheets or panels, including internal condensation.
- Deterioration of the panels caused by contact with green (unprocessed) lumber, wet lumber and/or wet storage stain caused by water damage and/or condensation.
- Presence of damp area and/or other corrosive materials in contact with or in close proximity to the panel.

This warranty does not apply in the event of deterioration to panels caused, directly or indirectly, by a contact with fasteners and sealants/waterproof agent. Buyer is solely liable for selection of suitable fasteners and sealant/waterproof agent to be used on SuperGalum steel roofing, siding panels, and/or in rainwater applications. KG Dongbu Steel will have information available to the Buyer to aid in selection of suitable products. For avoidance of doubt, the information provided by KG Dongbu Steel is not a warranty of performance under any conditions.

This warranty is subject to the stipulations, limitations and conditions listed below:

1. Dongbu Steel's liability for breach of this warranty shall be limited exclusively to the cost of either repairing non-conforming sheets or panels or, at Dongbu Steel's sole option, of furnishing sufficient sheet product, FOB Buyer's plant, to enable Buyer to replace the non-conforming sheets or panels.
2. KG Dongbu Steel shall not in any event be liable for the cost of labor incurred due to any non-conforming sheets or panels.
3. Buyer shall immediately notify KG Dongbu Steel, in writing, of any claims and KG Dongbu Steel shall be given a reasonable opportunity to inspect the panels claimed to be non-conforming. Adequate identification of the material involved in the claim must be provided by the Buyer, including date of installation, Dongbu Steel order number, coil number, invoice number and the date of shipment.
4. Buyer shall exercise diligence in the examining the inspection certificate from KG Dongbu Steel in order to minimize the cost of repair or replacement.
5. The limited warranty herein is made to and for the benefit of the original buyer and is non-transferable and non-assignable.
6. KG Dongbu Steel reserves the right to terminate or amend this warranty at any time (*except as to orders already accepted*), at its sole discretion, with a written notice to the Buyer.
7. This limited warranty herein is intended by the parties to constitute the entire, complete and exclusive understanding and agreement between the parties and is part of the purchase agreement of SuperGalum steel sheet. All prior, oral or written, statements are hereby excluded.
8. This limited warranty herein shall be governed by and interpreted in accordance with the laws of the State of California.

EXCEPT AS OTHERWISE PROVIDED HEREIN, KG DONGBU STEEL, ITS SUBSIDIARIES AND AFFILIATES, DISCLAIMS ALL WARRANTIES AND CONDITIONS OF ANY KIND WITH RESPECT TO THE PRODUCT, EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
